New Power for Debit Cardholders

Fraudsters have been making a lot of headlines lately. But now there's some good news for Pipefitters Steamfitters Credit Union debit cardholders. Our members now have access to an app called **CardNavSM by CO-OP**. It's the key to taking unprecedented, real-time control over your cards through your smartphone.



CardNav adds another level of security to your cards by letting you decide how and when they can be used, and alerting you when any types of transactions you specify take place to help identify and stop potential fraud from happening. You can even use CardNav to set personal spending limits that help you stay within your budget goals.



With CardNav, you can turn cards on or off in seconds, and use GPS to restrict transactions to businesses within a designated area. You can limit card use to specific merchants or purchases. You also can receive alerts when you're getting close to any personal spending limits you've set.

In just minutes, you can gain the security and control of CardNav by CO-OP. All it takes to get started is a free download from the Apple App Store or Google Play.

Loans

Summer time schedule making it hard to find the time for a loan appointment? The loan process does not have to stress you out! Most loans can be completed without an office visit. Start by submitting a loan application via **Pipeline Banking**. End with signing from the comfort of your own home or while you are out on the town using E-Sign. With E-Sign, qualifying members can sign loan documents using their personal computer, tablet, or smartphone.
