A few things to consider when deciding who you would like to have access to your accounts:

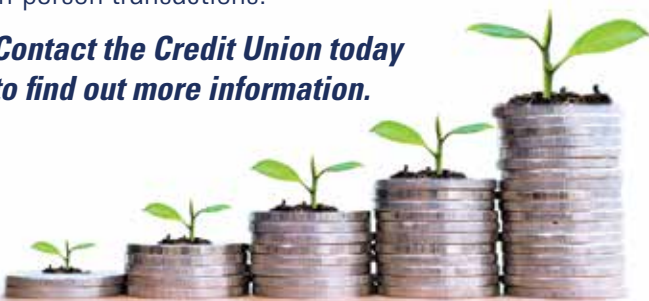
- Who are the joint owners on my membership and which accounts are they listed on?
- Who is listed as a beneficiary on my accounts?
- Is all of my personal information (*phone number, address, etc.*) up-to-date on my account?
- Do I want to obtain Power of Attorney (POA) paperwork in case I am unable to handle my accounts on my own?

If any of this information is missing or not up-to-date, it can cause serious delays in distributing your estate if something should happen to you. Speak to one of our Member Service Representatives to make sure your information is up-to-date.
